# Rain Ends but Pain Continues: Time for relief Measures. How do we recover from Rs.11,000 crores Loss?

The last few days have made life at KTCC (Kanchipuram, Tiruvallur, Chennai and Chengalpattu districts) in TN miserable for many. It is easy to blame anything or everything. However, there are sections of people like Street Vendors, Micro and Small-scale industries, GIG workers like Mob app-based delivery agents, Auto & Taxi Drivers with own vehicles who are attached or detached with Mob apps, Daily wage earners, Contractors, Perishable goods sellers, show room and traders situated in water logging areas whose life has gone for a toss. It takes months for them to come to terms with. Some recover and many go into deep coma. They are numbered close to about 25 lakhs of people in these four districts.

The population in KTCC alone is assumed to be 1.75 crores because most of them are here for earning their livelihood as we have more than 3.50 lakhs of industries in a spread of over - 12 SIDCO/ SIPCOT constructed industrial estates at Kakalur, Thirumalisai, Goomidipoondi, Ambattur, Guindy, Thirumudiwakkom, Oragadam, Siruseri, Sriperumbudur, Kanchipuram, Kodungaiyur, Maraimalainagar apart from Private created Industrial parks and IT sector office buildings.

As per the estimate of K. E. Raghunathan, National President of Association of Indian Entrepreneurs, the loss due to this heavy rain is expected to be over Rs.11,000 crores. The detailed estimates have been done and it spreads into a) business loss due to production stop, b) machinery or asset loss and c) Material loss.

It is unfortunate – the Government of TN has not taken this into account in their claim of loss due to the Cyclone. According to K. E. Raghunathan, National President of Association of Indian Entrepreneurs What TN government should do at this moment?

- Visit all the Industrial Estates by a high-level team to ascertain cause and sufferings and provide immediate evacuation of water and restoration of power as a priority.
- ❖ Create larger Strom water drain in all industrial Estate immediately. Make sure no water enters any premises in Government estate or private industrial parks.
- Create protection from Lake water entry points for those Estates prone to lake breach. Construct an obstruction wall around.
- Raise all EB cable, Transformer, Distribution box, Meter above water level to a minimum of 10 feet from ground level so that not to cut power during such times.
- Cancel for three months EB Fixed charges, Property Tax, Metro water and sewerage Taxes from all those Establishments situated in the 4 districts to allow them liquidity and recovery time.
- Set up a Facilitation centre at each estate for faster Insurance claims settlement, in partnership with the Industrial associations at the respective locations and conduct a camp to ascertain claims.
- Offer Scheme like state govt guarantee for 20% ad hoc increase in loan sanctioned limits like ECGLS of Government of India
- ❖ TIIC to offer affected industries in these districts loan at concessional interest loan to refurbish or repair or get new machines spoiled due to rain.
- Offer Raw material on credit to Micro and Small enterprises through TANSI.
- Write to RBI to offer 3 months moratorium for term loans or offer that as loan from TIIC immediately.
- Clear all pending payments held by SU and Government Departments to help them have sufficient cash flow.
- ❖ Keep all GST notices and other claims pending for three months so that they are focused on recovery.

He also suggests that on a focus during upcoming Global Investor Meet - TN Government must decentralise large Industries in and Around Madurai area so as to decongest KTCC. This has become evident as it is impossible to hold any further dense population in KTCC. In the end, K E Raghunathan asks - Will they do? And replies saying, they Should if serious about revival of MSMEs in the State.
